WAIVER, INDEMNIFICATION, and RELEASE OF LIABILITY

As partial consideration for the willingness of Big Amazon Fish, LLC ("Big Amazon Fish"), to provide a Big Amazon Fish adventure, the undersigned acknowledges and agrees to the terms of this Waiver, Indemnification & Release of Liability ("Release") as follows:

1. The undersigned acknowledges that participation in a Big Amazon Fish adventure involves not only travel to and from Brazil, but also considerable travel and activities, fishing, boating and hiking, in undeveloped and remote parts of Brazil, which involves certain risks, foreseen and unforeseen - including but not limited to: risks of injury, disease, illness, death, medical problems, unavailable or insufficient medical care, crime, political instability, animal attacks, fish attacks, insect attacks, spider attacks, amphibian attacks, reptile attacks, or any other unforeseen attacks, etc. The undersigned acknowledges that participation in a Big Amazon Fish adventure is voluntary, and hereby assumes all risks in connection with participation in a Big Amazon Fish adventure, whether such risks are foreseen or unforeseen.
2. The undersigned hereby releases, holds harmless, waives any claim against, and agrees to indemnify, Big Amazon Fish from any and all liability, claims, or demands for damages arising out of any personal injury, sickness, death, loss of property, property damage, or any other costs or expenses, including attorney's fees, incurred by the undersigned, during the course of, as the result of, or in any way connected with the undersigned's participation in a Big Amazon Fish adventure, whether such damages, costs, or expenses arise out of the negligence or carelessness of Big Amazon Fish or otherwise.
3. This Release extends to and includes all directors, employees, agents, principles, contractors, representatives, successors, assignees, sponsors, volunteers, associates, affiliates, attorneys, and insurers of Big Amazon Fish; to all other persons and entities subject to liability derived from the conduct of Big Amazon Fish; and to any vicarious liability of Big Amazon Fish based on the conduct of any other person or entity.
4. This Release is binding upon the family, estate, heirs, representatives, successors, assignees, officers, agents, and employees of the undersigned.
5. The undersigned hereby represents that he/she has had a recent medical examination, or otherwise has good reason to believe that he or she is physically fit and capable to participate in a Big Amazon Fish adventure in the Amazon region of Brazil, and assumes the responsibility of fitness and capability to participate in a Big Amazon Fish adventure. The undersigned understands that Big Amazon Fish does not provide or retain any medical professionals in connection with its adventures and further agrees that the rendering of any medical or other services to the undersigned by, or at the instance, of Big Amazon Fish, or any of the persons or entities described in Paragraph 3, above, does not constitute a waiver or an admission of liability to provide or to continue to provide any such services.
6. The undersigned hereby authorizes Big Amazon Fish and all persons or entities described in paragraph 3, above, if they choose to do so to provide any medical or emergency aid or assistance, but waives any claim of a legal obligation they have to do so and agrees to indemnify Big Amazon Fish for any such claim, action, or cause of.
7. The undersigned expressly agrees that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of Utah, and that if any portion of it is held invalid, it is agreed that the balance shall notwithstanding, continue in full legal force and effect.
